Our Lady's Primary School is a smaller than average primary school that serves an urban community within the town of Barnstaple. The proportion eligible for free school meals is 33%, which is slightly above the national average. The proportion eligible for pupil premium funding is 35%. The proportion of pupils from ethnic minority groups is 18%. The proportion of pupils identified by SEN support is 24%; SEN support and with an EHCP 4%.

Attendance rates are currently at 93%
